PRECAUTIONS

PREVENT ACCESS TO UNAUTHORIZED PERSONNEL.

Harmful or fatal if inhaled. Do not get in eyes, on skin, or on clothing. Do not breathe dust. Wear goggles or face shield, approved respirator (NIOSH/MSHA TC-23C-54 or equivalent), a chemical resistant suit (e.g. Tyvek), and rubber gloves when handling. FIRST AID:
